

Clinkt Privacy Policy

1. Introduction

1. Data Collected

We collect various types of data in connection with your use of the Site:

Your personal data is stored on secure servers provided by Scaleway (Société par Actions Simplifiée with a capital of 214,410.50 euros, registered under SIREN number 433 115 904, headquartered at 8 rue de la Ville l'Evêque, 75008 Paris).

1. User Access and Rights

In accordance with the GDPR, you have the following rights regarding your data:

- Right of access;
- Right of rectification;
- Right of deletion;
- Right to restrict processing;
- Right to data portability.

1. Data Retention

Personal data is retained for as long as necessary to fulfill the purposes for which it was collected. Files and media uploaded by users are retained for 7 days in our database, after which they are permanently deleted and cannot be recovered.

- To comply with a legal obligation;
- In the event of a report or request from law enforcement or judicial authorities;
- To protect the rights and safety of Clinkt and its users.
